### AGREEMENT AND RELEASE FROM LIABILITY

#### -VOLUNTARY PARTICIPATION -

I, ....., acknowledge that I have voluntarily agreed to engage and otherwise participate in the grappling competition held at the Melbourne Sports and Aquatic Center on September 12<sup>th</sup> 2009.

I understand that this type of sporting practice is inherently dangerous, regardless of the level of supervision. Injuries may occur due to physical situations, including – a slippery floor surface, an over-zealous partner or a combination of any number of circumstances. It is clear to me that my voluntary participation in this activity will expose me to the risk of injury; and that any amount of time spent engaging in this activity only makes it more likely that, as in any sport, injury may well occur at some time.

I AM AWARE THAT THE ACTIVITIES MENTIONED IN PARAGRAPHS ONE AND TWO OF THIS AGREEMENT CONSTITUTE A POTENTIALLY DANGEROUS ACTIVITY IN WHICH INJURY MAY OCCUR. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH FULL KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT ALL RISKS OF INJURY OR DEATH WHEN SO ENGAGED IN SAID ACTIVITIES.
